

RiverSource®, Threadneedle® and Seligman® Fund Guide — Addendum to Application

The RiverSource®, Threadneedle® and Seligman® funds (herein after collectively referred to as RiverSource Family of funds) offer different classes of shares. Note: New purchases of Class B shares will not be permitted if your Rights of Accumulation are \$50,000 or over, and new purchases of Class C shares will not be permitted if your Rights of Accumulation are \$1,000,000 or over. See “Sales Charges, Initial Sales Charge — Rights of Accumulation” in the fund’s prospectus for information on Rights of Accumulation.

On April 30, 2010, Ameriprise Financial, Inc., the parent company of RiverSource Investments, LLC, acquired the long-term asset management business of Columbia Management Group, LLC, including certain of its affiliates, which were, prior to this acquisition, part of Bank of America.
